IN NO INCIDENT WILL THE MISSOURI STATE FAIR COMPLEX OR THE UPHA CHAPTER V HORSE SHOW BE HELD RESPONSIBLE FOR ANY LOSS OR DAMAGE IN ACCIDENTS OR DAMAGE TO PERSONS OR ANIMALS OR LIABLE FOR ANY INJURY SUSTAINED IN ANY WAY TO EXHIBITORS, SPECTATORS, EMPLOYEES OR ANY OTHER INTERESTED PARTIES. NOR WILL THE AMERICAN ROYAL COMPLEX OR THE UPHA CHAPTER V HORSE SHOW AND ITS MANAGEMENT BE RESPONSIBLE FOR ANY ARTICLES LOST OR STOLEN. IT WILL BE THE CONDITIONS OF ANY ENTRY AT THE MISSOURI STATE FAIR SOCIETY HORSE SHOW TO HOLD BLAMELESS ANY PARTIES CONNECTED TO THE SHOW FOR ANY TYPE OF LOSS. EVERY CLASS OFFERED HEREIN, WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULEBOOK, WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

ASHA MEMBERSHIP STATEMENT—Owners, riders, drivers, handlers and trainers of American Saddlebred horses showing at open shows recorded with ASHA must be current ASHA competing members for points counted for KSF/WCHS Qualifying, National Pleasure and ASHA High Point Awards. Effective February 4, 2019, any individual that appears on the Safe Sport or USEF banned or suspended lists cannot be in attendance, compete or participate in such competition in any manner, including as a trainer, coach, owner or exhibitor of horses or ponies. **The Missouri State Fair Society Horse Show requires that every trainer and/or horse owner MUST be a current member of American Saddlebred Horse Association with copy of current card.**
